

# DEAD IN GATES MINE--25

## 16 Bodies Recovered; Day Boss Horne Dead; Explosion Was Local

Of the 25 men known to be dead, bodies of 16 have been removed from the shaft at 2 o'clock. The other nine had not yet been reached in the workings but are undoubtedly dead, all experts on the scene agreed.

Most of the bodies were mutilated and many were identified only by their check numbers or clothing. Most of the bodies were singed, blackened and burned.

At first it was believed 26 had been killed, the name of Tony Coppetti being included in the list. Coppetti, however, turned up as one of the workers in the rescue party.

Thomas Horne, the day boss who lost his life, was the victim of his own generous friendship. Jim Gillen, the regular night boss, arrived at work last night at 5:45, just a few minutes too late to change his clothes and make the shift. Horne offered to work a double trick, substituting for Gillen on the night shift, and thus protecting his job. This cost him his life.

The 16 bodies already recovered have been loaded on a special rescue car and were taken to Masontown this afternoon to the morgue of Undertaker H. A. Johnston. The remaining bodies will be sent to Masontown as soon as they are recovered.

The explosion is now believed to have occurred between 1:30 and 1:45 this morning and was purely local. It happened at the face of No. 2 Flat at Butt 19 and killed every man in the immediate area. It spent its force in a short distance, however, and workers in other parts of the mine were not injured.

There were 50 night cutters in the mine, the day shift having about 160 cutters. Most of the dead men were cutters. Others were transit men.

As soon as the word was received the Frick mine rescue teams of Hecla No. 2, Leisenring and Buffington were mobilized and hurried to the spot. They were followed by the special rescue car from Brownsville in charge of Mine Inspector E. E. Girod.

This train contained Brownsville physicians, nurses and first aid men with emergency equipment and made a record run up the river. There was little for the staff to do, however, the men being all killed outright. Profers of aid were received by the Frick officials from Orient and other first aid teams, and these were held in reserve.

The work of rescue was begun without loss of a moment. Under the direction of Company Mine Inspector Patrick J. Mullen and Harry Millward, a volunteer rescue squad was hastily organized and entered the smoking shaft. State Mine Inspector E. E. Girod, who was also on the scene early, was overcome by gas and resuscitated with difficulty. Gas masks were found necessary to penetrate many of the workings.

Fortunately today was a lay-off day at Gates and the smallest number of men in some time was in the mine. The normal number of men working at Gates now runs about 650 but today there were only 50 in the openings.

## Carload of Star Beer Seized by Agent Exnicios

 Pittsburgh, Feb. 2.—A railroad car loaded with supposed beer, manufactured, according to General Prohibition Agent John Exnicios, in charge of the local office, by the Star Brewing company, of Greensburg, was seized in the Coleman yards of the Conemaugh division, Pennsylvania railroad, late yesterday afternoon.

Agent Exnicios learned of the arrival of the car and ordered two agents to the scene. Samples of the contents of the bottles and barrels were taken and returned to Agent Exnicios, who stated that the contents would be analyzed to determine the alcoholic content. According to Exnicios, the car contained 273 cases, 25 full barrels and 52 one-half barrels of the supposed beer and was consigned to John Bortz, New Kensington.

Prohibition agents late yesterday afternoon went to the car and placed government seals on it. The contents will be removed to a government storage house today, it was stated, and held pending an investigation.

The Star brewery was built and operated by Frank Madas, formerly of Fayette county. The brewery was recently closed by prohibition agents and fined \$3,000.
