Inspection Under Way At Working — Charmbury To Get Report

Deputy-State Mine Secretary Gordon E. Smith joined State and Federal mine inspectors today for an onthe-spot investigation of the explosion which ripped through the Glen-Nan Coal Company's Forge Slope at Newport Township Tuesday night. Two men were killed outright and two others died last night at Nanticoke State Hospital. Three other miner workers are listed in critical condition at the hospital.

Deputy Secretary Smith, along with six inspectors, entered the mine at 8:30 a. m. to determine the exact cause of the explosion. Preliminary reports indicated that the blast resulted from methane gas under pressure. It was reported today that the full-scale examination of the workings will probably substatiate the original belief.

The inspection party emerged from the slope at about noon today and Mr. Smith reiterated his earlier statement that the mine explosion was probably caused by methane gas.

Smith said: "Methane gas

smith said: "Methane gas apparently liberated from an adjacent robbed area mixed with air as it was released into the working panel, thus causing the explosion."

Will Meet Charmbury

Once today's inspection completed, Mr. Smith will meet with State Secre-Mines tary H.Beecher Charmbury and report on the inspectors' findings. The meeting will probably take place tomorrow at Hazleton as Sec. Charmbury be-



gins an exten-paul Romanowski sive tour of the Anthracite region. He is inspecting the strip mining operations throughout the southern hard coal fileds. He recently completed a swing through the Wilkes-Barre-Scranton area to get a first-hand report on strip mining conditions here.

Accompaning Mr. Smith on today's tour of the Forge Slope were State Mine Inspectors Kenneth Lee of Wilkes-Barre; Thomas Beaney, Wyoming, and Willis Devens, Forty Fort. Also, Federal Mine Inspectors Joseph Lindsey, Wilkes-Barre; George Culverhouse, Kingston, and Elwood Menta, Plains Township. The two mine workers who died at Nanticoke State General Hospital last night were:

Paul J. Eckrote, 38, of 14 Haefele street, Lower Askam, Hanover Township, a miner, and Paul Romanowski, 54, of rear 160 East Union street, Nanticoke, a bratticeman.

Eckrote died at 7:50 p. m. of burns and injuries to the face, hands, chest and back. Romanowski passed away at 8:50 of burns and blast injures to the head, face, chest and upper arms, as well as internal injuries.
